Criminal intelligence IT specialist ABM launches anti-knife crime film

Nottingham, 11th December 2008 – In response to the escalating problem of knife crime, exacerbated in some cases by the unwillingness of witnesses to come forward and give evidence, criminal intelligence IT specialist ABM, has today launched a new film that shows how its computer software can help police in their investigations.

Alastair Luff, Managing Director of ABM, commented "Knife crime is an emotive and very serious problem for many police forces. Although 23 young people in London alone have died after being stabbed, this is a nationwide problem, with one in five teenagers have admitted to carrying a knife. Our
